Perimeter trails and a trail through the center of the property provide easy access to sneak into the best spots. An approach and building pad have been cleared and prepared with class 5 gravel. Electric service runs along the east boundary of the property. Located just south of Pelican Rapids with easy access via a minimum maintenance road along the east side of the property. The property is bordered by the Pelican River and approximately 470 acres of Federal Waterfowl Production land to the west, making it almost impenetrable from the west. The northwest corner of this property has an open meadow area of about 6.5 acres. There are several smaller open areas on the north border, center and southeast section of the property that would be ideal for smaller food plots. MN DNR Permit Area 239 is a two deer limit area providing plenty of opportunity on this land. Schedule a showing to explore this beautiful hunting property and prepare for the next hunting season.

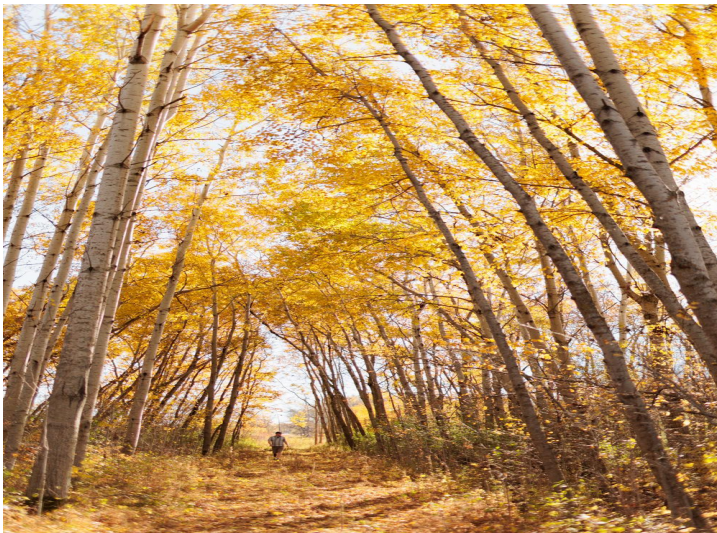

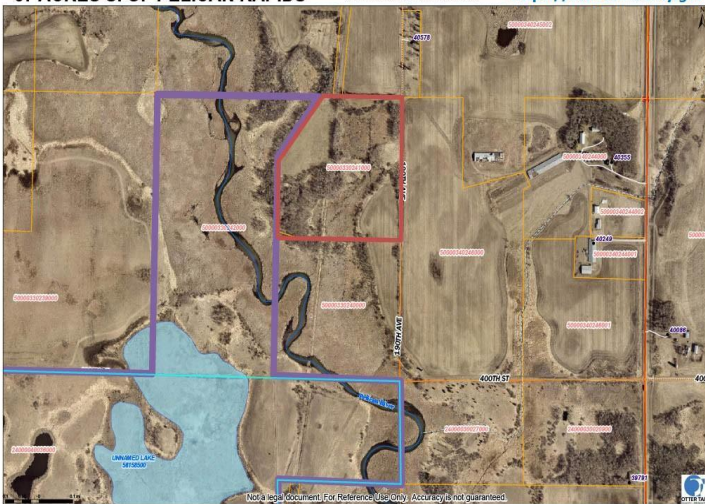
